This is with reference to your RTI application dated 15/02/2020 (Registration Number MHOME/R/P/20/00359 dated 27/02/2020) received in this Dte. on 28/04/2020 through MHA letter No. II-45020/2/2020-Pers-II dated 04/03/2020 in which you have sought certain information/attested copies of the certificates which were given till date i.e. 15<sup>th</sup> February 2020 by the MHA, GOI to the 40 CRPF security personnel who died on 14 Feb., 2019 for country etc. under RTI Act.

2. After careful consideration of your application on the subject along with provision contained in RTI Act, it is to inform you that,

- a) Security forces including CRPF are exempted to provide information except information related to allegation of corruption/ violation of human rights under Section 24(1) of RTI Act-2005.
- b) In the instant matter, there appears to be no violations of Human Rights as well as facts of the case do not attract the allegations of corruption. Moreover, your application does not make any reference to such allegations. Hence this department is not liable to provide any information in this regard to you under RTI Act-2005.
