**DECLARATION OF FINAL REVISED RESULT FOR THE POST OF SI/GD THROUGH LDCE-2016**

Reference is invited to the notice dated 19<sup>th</sup> December, 2018 wherein declaration of revised result for the post of SI/GD through LDCE-2016 was published in website.

2. Notification to fill up vacancies for the post of SI/GD through LDCE-2016 was issued vide this Dte Signal No. R.II.25/2016-Rectt.(SI/LDCE-16)-DA-II dated 07/09/2016. Written examination was held on 05/02/2017 and result of which was declared on 08/02/2017 on website www.crpfindia.com. After completion of all stages of recruitment final result of selected candidates was declared vide this Rectt. Dte signal dated 18/05/2017. Some candidates had filed Writ petitions claiming that some of the answers to the questions were wrong. Accordingly, all questions and answers of all series were re-checked by a board of officers and necessary corrections made in all answer keys. To give fair chance to the candidates, fresh answer keys of all sets alongwith question papers were uploaded on CRPF website i.e. [www.crpf.gov.in](http://www.crpf.gov.in) on 20/09/2018 for inviting objections from the candidates, if any, with regard to correctness of answers to all questions in papers of all series.

3. On the basis of objections received, a Board of Officers was again detailed to examine the objections and fresh/revised answer keys of all sets prepared. Answers of some of the questions were changed and some questions were discarded after uploading of answer key on website on 20/09/2018. Marks for right answers as per final answer key have been given to the candidates. Marks for wrong questions/all wrong answer options were given to those candidates who had attempted them. As per the orders of Hon'ble Supreme Court of India in Civil Appeal No. 6547 of 2014 (Special Leave Petition (C) No. 2702/2014) in case of Anil Kumar & Ors Vs State of UP and Ors wherein full marks were granted to candidates who attempted the wrong questions.

4. The revised result of written examination of SI/GD through LDCE-2016 has been prepared as per directions of Hon'ble High Court of Delhi vide Court order dated 27/09/2018 pronounced in WPs(C) filed by some candidates and is attached with this notice.

5. Based on the revised result/merit, cut off marks for last candidate selected in each categories is as under:
